

WHEREAS the founders being desirous of settling in trust a sum of Rupees Twenty five Thousand (₹ 25000) in favour of the said trust named below for the beneifit and welfare of the person named hereunder.

- The name of the trust that is created here by shall be called "SAIDUR RAHMAN EDUCATIONALAND SOCIAL WELFARE TRUST" hereinafter called in short S.R. EDUCATIONAL AND SOCIAL WELFARE TRUST
- The registered office shall be at MAGARDAHI GHAT 2. (NEAR OIL DEPOT, DIST.-SAMASTIPUR, PIN-\$48101 IN STATE OF BIHAR, (INDIA)


3. The objects of the Trust :

- (a) To provide fees, books, equipments, freeships and/ or scholorships to deserving students.
- (b) To feed poor students and to start fees student homes and fees hostels.
- (c) To conduct seminars/workshops and arrange special tution/training for students.
- (d) To provide/assist in setting up laboratories
- (e) To make donations of the other public charitable trusts/institutions recognised under section 80-G of the Income tax Act, 1961.
- (f) To set up and operate schools/colleges.
- (g) To conduct nutritional and health services.
- (h) To conduct/operate programmes for providing nutritional assistance e.g. to operate a school/lunch/ food programme for needy women which shall be provided/conducted/distributed free of charge.
- Testing of diets from nutritional view point.
- (j) To render assistance to poor patients by providing medicines, etc. provision of health care, preventive medical services (including dental services)
- (k) Assistance to hospitals in setting up the various facilities such as Blood Bank, Eye Bank, Burn Centers, etc. for the poor patients.
- Provision of outdoor dispensary or assistance thereof and also to run "Mobile" medical services.
- (m) Conduct education in health care of provide assistance in the provision of primary health care education.
- (n) To set up hospitals/nursing homes for children/ women.



- (o) To render assistance to the handicapped.
- (p) To provide monetary assistance and social service in case of natural clamities.
- (q) To render financial assistance to the poor and the disadvantaged.
- To promote and advance moral education, charity and general welfare of the people.
- (s) To promote general, secular, scientific educational vocational and prfessional education of members of muslim minority community in particular and other citizens of the state of Bihar and India in general
- (t) To impart Islamic and regligious as well as secular educational. Techinical and vocational Institutions such as schools, colleges. Research centre, charitable hospitals and also publish periodical books and generals for advancement of the said object.
- (u) To establish and counduct institution, boarding house, hostels, dor-mitories etc. for students, teacher and visitors in need of such assistances and care.
- (v) To establish and organise cultural centers,
 libraries teaching rooms, lecture rooms, evening
 classes, tutorials seminars, lecturers series, sports
 facilities etc. to faciliate the people in general and
 students in particulars.
- (w) To prepare and publish sutable and useful Islamic literature and to provide teaching aids and other necessary materials to be utilized in upgrading the educational standared of the Institution.

- (y) To grant scholarships and stipends to the deserving students to encourage them in education and provide opportunities for higher studies for the muslims in particular and others in general.
- (z) To co-operate and Co-ordinate with the Institution having similar aims and objects.

5. GENERAL FUNCTION OF THE TRUST :-

This trust shall be managed by Indian Trust Act. 1882. The trustees shall be competent and are hereby empowered to:

Member

- (a) Receive any more and further assets in any shape or from as and when given by the author of the Trust, any of the trustees or any other presons or institutions.
- Collect funds by donations, subscriptions, grants, presents or contributions.
- (c) Invest the funds too the extent necessary in accordance with the provisions of section 13 (1) read with section 13(5) of the Income Tax, 1961 or such oter sections of the Income Tax Act as amended form time to time so that the income of the trust will be exempt from Income Tax.
- (d) Acquire on lease, purchase, or otherwise sell mortage lease out or transfer in any other manner properties (movable or immovable) construct buildings and effect other improvements for the purpose of the trust.
- (e) Help and render relief to the poor in all possible way.
- (f) Make donations or contributions for attaining and in furtherance of the objects of the trust.
- (g) Borrow for the purpose of the trust on personal credit of the trustees with or without charges or responsibility upon the assets of the trust.
- (h) Meet necessary expenses to be incurred in connection with the execution and administration of the trust.

- Establish centers in different parts of the country for carrying out the objects of the trust.
- (j) Do all or any of the aforesaid things transactions or matters and do all other things as are incidental or conducive to the attainment of the aims and objects of the trust.
- (k) To appint the attorneys / advocates and staffs to delegate to such attorneys adovates and staff all or any or the power vested in them under these presents and from time to time remove such attorneys and advocates and staffs and appoint other or others in his/ her or their place.

GENERAL ADMINISTRATION :-

- All or any of the powers vested in or exercisable by the trustees
 as per this deed of trust shall be capable of being performed or
 exercised by a majority of the trustees present at the meeting of the
 trustees and any action or decision of such majority shall be valid
 and effective as it would have been if doen by all the trustees.
- The trustees if they so choose and for the benefit of the trust may
 delegate by means of a resolution in writing any or all of their
 powers to any one or more of them or any other person for such
 time and purpose as they deedm fit.
- 3. The trustees shall elect from among themesives a secretary and a treasurer and they shall hold office for a period of three years the trustees shall take charge of the trust assets and hold and administer the same in accordance with the terms of this deed all bank accounts shall be operated by the treasurer jointly with the secretary of the trust.
- 4. The office of the president of the trust shall be for life on the death of the secretary the person succeeding him shall hold office for life the other trustees shall hold office for period of five years from the date of appointment or nonination as trustees.



- 5. Any trustee may at any time resign his office of trusteeship by giving one months notice in writing to his co trustees and upon the expiry of the period such trustee shall be deemed to have vacated his office, the office of the trustee falling vacant either by death or by resignation or expiry of 5 years period may be filled bynomination by the persident of the trust.
- The meeting of the trustees shall be presided over by the
 president
 of the trust and in his absence the trustees present in the meeting
 shall elect one of them to preside over that meeting.
- 7. The office of the trustees will be honorary but the trustees will be entitled to be paid their actual travelling expenses and other incidental charges incurred by them in attending the meetings and in connection with carrying out the objects of the trust.
- 8. The trustees shall have all powers as may be required for the proper conduct of the affairs of the trust. The trustees shall have the power to initiate prosecutioins and defend legal proceedings as may be reasonable and proper for safeguarding the assets and properties of the trust as alos the trust funds and interest. Any action teken by such trustees in this regard shall be deemed to have been taken and ratified by all trustees.
- The trustees shall at their descretion acqure purchase or sell
 immovable properties or movable properties in the course of
 managing of trust. However any sale of immovable property shall
 require prior consent of at least 2/3rd majority of the trustees.
- No income of the trust shall be applied for the personal benefit either of the trustees or of the settlor.
- The objects of the trust shall be achieved without involving any activity for profit.
- The trustees and the members of their family shall not be entitled to the benefits of the trust.

- 13. The trust formed is irrevocable.
- 14. The funds /income of the trust shall be solely utilised for achieving the objects of the tust and no protion of it shall be utilised for the benefit of the trustees by way of interest bonus dividend profit etc.
- The benefits of the trust shall be open to all Indians irrespective of caste creed or religion.
- The accounts of the trust shall be regularly maintained and audited by a chartered Accountant every year. The accounting year for the trust shall be from 1st April to 31st March each year.

7. FUNCTIONS AND DUTIES OF THE OFFCIALS OF THE TRUST.

1. Functions of the President :-

- (i) The president will preside over the meetings of the trust but in absence of the president the members of the governing body will elect a president out of themeslves to preside over the meeting.
- (ii) The president will call the meetings of the trust therough the secretary as per rule.
- (iii) The president will exercise general supervision over the affairs of the trust.

Functions and duties of the Secretary.

- (i) The Secretary shall be the executive officer of the trust and shall conduct all official correspondence under his signature and shall have supervisory powers over all the institutions of the trust.
- (ii) The Secretary shall convene all the meetings of the trust on due dates and give intimations there of to the members.
- (iii) The secretary will prepare the agenda of the meetings with the help of member/members of the trust.
- (iv) All the contract shall be entered into his name or behalf of the trust.

- (v) It shall be his duty to see that proper accounts are kept and documents are prepared as per the rules.
- (vi) The secretary shall operate the bank accounts jointly with any member of the trust who enjoys the confidence of the governming body.

3. Functions of the Treasurer.

- He will be jointly responsible for receipt and expenditure of the trust.
- (ii) He shall operate the bank account jointly with the secretary.

4. Functions of the board of Trustees.

- (i) The board of trustees shall be entitled to appoint persons or agents with or without remuneration and on such terms and conditions as they may think proper for carrying out the aims and objects of the trust.
- (ii) Is shall be law full for the board of trustees to settle or determine all metters of interpretations of these presents.
- (iii) The trustees can make any amendment in the rules in the in terest of the trust by a majority vote of 2/3.

5. Meeting, Agenda and Quorum.

- All meetings of the trust shall be called and agenda will be prepared by the secretary under the direction of the president.
- (ii) Decisions at any meeting of the trust shall be taken by a majority of vote.
- (iii) Presence of 2/3 member of the trust shall be the quorum of any meeting.

Remuneration of Members. 6.

(i) Nothing will be paid to the members of the trust inculding the president, secretary and the treasurer as remuneration for rendering services for the trust but if any member goes out of station related to the affairs of the trust T.A. & other expenses will be paid to him on submission of bill.

7. Desolution of the Trust.

(i) The trust formed is irrevocable. In case of desolution of the trust the remaining assets of the trust shall be haded over to the donors.
